

Lightcast Inc. 1 Year Warranty

Lightcast Inc. warrants this product against defects in materials and workmanship to the *original (end user)* purchaser for a period of one (1) year from the date of shipment.

To obtain warranty service, the purchaser must first call Lightcast Inc. for an RMA number, then return the product to Lightcast Inc. for repair or replacement. In the event that a defect, malfunction or failure occurs or is discovered during the warranty period, LCI will repair or replace at its option the product or component part(s) which shall appear in the reasonable judgment of LCI to be defective or not to factory specifications. A product requiring service is to be returned to LCI along with the sales receipt or other proof of purchase acceptable to LCI and a statement describing the defect or malfunction.

Purchaser shall prepay shipping charges for products returned to Lightcast Inc. Lightcast Inc. will pay for return of the products to purchaser, except that purchaser shall pay all shipping charges, duties, and taxes for products returned to Lightcast Inc. from a country other than the United States.

Lightcast Inc. makes no other warranty of any kind with regard to this product. Lightcast Inc. shall not be liable for errors contained herein or for incidental or consequential damages in connection with the furnishing, performance, or use of this product.

Lightcast Inc. warrants that this product is new. Lightcast Inc. makes no other warranty, either expressed or implied, with respect to this product. Lightcast Inc. specifically disclaims the implied warranties of merchantability and fitness for a particular purpose.
